Supervisor Trout opened the Public Hearing at 7:00 PM, and introduced Local Law Number 5 of the Year 2018

A Local Law authorizing a Six Month Moratorium on issuance of Chapter 80 Mining and Excavation Permits.

Supervisor Trout then opened the floor to comments:

Mr. Lee Henry addressed the Board and said he is Vice-President of the Concerned Citizens Group and they are very supportive of this Local Law. Mr. Henry said that this board authorized the revision of the Town's Comprehensive Plan in the year 2000 and the board approved the revision of this plan in January 2017. The revised plan in the vision and goals section, recommends that the town amends its local laws to ensure that commercial mining is not legal in the Town of Waterloo.

Mr. Henry also said that Local Law Number 5 is in furtherance of that recommendation to prevent any applications for mining in the Town of Waterloo until the codes can be revised.

Mr. Henry concluded that Concerned Citizens of Seneca County strongly support passage of Local Law Number 5 of 2018.

Mr. Robert McGill addressed the Board and said the moratorium is a "politically correct" thing to do and is basically meaningless legislation.

Mr. Kyle Black from Seneca Meadows also addressed the Board and advised the Board to consider existing mining and wants to make sure all those permits are excluded. Mr. Black said

mining has been allowed in this town for many years and this board has approved multiple mining permits that have been successfully carried out at their facility.

There were no other comments made by the public.

## **NEW BUSINESS:**

Supervisor Trout asked Town Accountant, Lisa Hochadel to explain about a new insurance consortium plan that Seneca County is planning on attaining for County Employees. Lisa said that Tompkins County has a Health Insurance Consortium and said Seneca County is planning on changing their Health Insurance to what Tompkins County pending union ratification. She said by taking this plan the county will save approximately a half million dollars

a year. Lisa said it would still be Excellus but it's a cheaper rate due to the volume of customers.

Lisa said Councilman Pfeiffer asked her to investigate the possibility of considering this plan for Town Employees. Lisa said there could be significant savings to the town. She asked the board for permission to push and compare numbers and benefits to see if this plan would benefit town employees. Lisa also said the only problem is that it's a short deadline of September 1, 2018.

Supervisor Trout said that after Lisa compares this plan against our old plan, they will present it to the town employees to get their input.
