MINUTES
INFORMATIONAL MEETING
REGULAR TOWN BOARD MEETING
MARCH 29, 2016

Supervisor Westfall introduced Mr. Pat Nicoletta, Project Engineer from the MRB Group who presented an overview on the proposed Route 96 Watermain Project. (Copy appended to the minutes)

Mr. Nicoletta said this project includes homeowners who live on Route 96 between Mills Road and Brewer Road. There are a total of 24.25 Equivalent Dwelling Units in this proposed water district. Mr. Nicoletta gave the cost comparison between using Municipal Forces versus an Outside Contractor doing the work. The comparison is as follows:

CONTRACTOR INSTALLED:

Estimated Cost, \$253,195, Anticipated Annual Debt, \$12,787

Cost per EDU (based on 24.25) is \$528.00

Commodity Charge is \$307.00 (Based on 50,000 gallons of water per year)

Total Anticipated Cost (Single Family Home) is \$834.00

CONSTRUCTION UTILIZING MUNICIPAL FORCES

Estimated Cost, \$200,000; Anticipated Annual Debt, \$10,100

Cost per EDU (based on 24.25) is \$417

Commodity Charge is \$307 (Based on 50,000 gallons of water per year)

Total Anticipated Cost (Single Family Home) is \$774.00/year

Cost Difference is:

\$111.00 PER YEAR

Mr. Nicoletta said that this proposed water district can be combined with the newly completed water Project of Reed Road, Kings Row, Hecker Road, Mills Road and NYS Route 96. This consolidation would result in a greater cost savings to all affected homeowners. The cost comparison is as follows:

COMMITTEE REPORTS:

Councilman King said that the Highway Department is making preparation to start the Hecker Road Water Project in the spring. He also said they are starting to get quotes back for the 5 and 20 Sewer Project to add dioxide to the wastewater collection system to help correct the corrosion problem with the concrete manholes.

Councilman Rodger said they had a Comprehensive Plan Meeting, March 15th, and MRB is in the process of drafting up the Plan for review by the committee. He said the plan should be presented to the Town Board by June and if there are no revisions, a Public Hearing can be scheduled.

DEPARTMENT REPORTS:

Highway Superintendent, Joe Mull said his department is starting to put the hydrants together for the Hecker Road Water Project. He also said they are working with a consultant to show his department how to put the pipe together as this is the first time his department has undertaken this type of work.

Dog Control Officer, Dallyn Jenkins said she has issued two tickets, seven warnings and has only impounded one dangerous dog for the month of February.

Supervisor Westfall welcomed Mrs. Alison Messecar a new town employee who was hired to replace Joyce French and Marlene Shade who are retiring this year.

Assessor/Code Enforcement Officer, Jim Cleere said he has been out doing field reviews the last couple weeks and will be sending out the certificates of compliance for all completed and approved projects for 2015. He also said the tentative roll will be turned in this April. Jim also said he has the Equalization Rates for Waterloo for 2016, the Town was at 95% and after the state did a mandatory mini revaluation the town came in at 90% Equalization Rate.

Supervisor Westfall asked Jim when grievance night is and Jim said it's always the 4th Tuesday night in May which this year is May 24^{TH, from} 4:00 to 8:00 PM. Jim also said if any homeowners had changes in their assessments for 2015, they are sent a letter four weeks prior to grievance night. This gives the homeowners a chance to discuss their assessment and possible come to a stipulation agreement before grievance night.

SUPERVISOR COMMENTS:

Supervisor Westfall said there is much going on in the Highway and Water Department with the anticipated water lines being installed.

Supervisor Westfall also said there will be two retirements this year, Joyce French who is retiring in April and Marlene Shade who will be retiring in May. Supervisor Westfall said they both will be missed and wished them well in their retirement.
