MINUTES REGULAR TOWN BOARD MEETING JULY 26, 2021

PRESENT:

Supervisor Don Trout, Councilman Mike Pfeiffer, Howard Strader, Tyrone Thomas, and Bob Lotz.

ALSO PRESENT:

PLEDGE OF ALLEGIANCE:

Supervisor Trout led everyone in the Pledge of Allegiance.

FIRE EXITS:

Supervisor Trout indicated where the fire exits were located.

PETITIONERS OF THE FLOOR:

Mr. Joe Wukitsch addressed the board with concerns about the Host Agreement the Town signed with NextEra Energy Resources. He said last August he met with Supervisor Trout regarding using intervenor funds to do a real estate study on the impact the solar farm would have on our community and property values.

Mr. Wukitsch said there was a study done by the states of Massachusetts and Rhode Island and they have strongly indicated that real estate values within a mile and a half of a solar farm have decreased by 5 to 7.5 percent.

Mr. Wukitsch said he had hoped that the Community Host Agreement would have incorporated home values into the Host Agreement. He also asked why there wasn't more involvement from the community before the agreement was signed.

Supervisor Trout said there is an implication by the title" Community "that the Community should be involved in the host agreement, but it's just that, an" implication". Supervisor Trout said the Community Host Agreement is for the protection of the people and that is their most utmost concern. The town board does not necessarily need to get input from the community for them to negotiate the Host Community Agreement.

Mr. Wukitsch said near Buffalo there is a solar farm named Cypress Creek and he understood that there was open communication and transparency between the Town and the Solar Company. Mr. Wukitsch said he doesn't feel that is the case with Trelina.

Mr. Wukitsch also said its incumbent that this governing body sends out a message to the governing powers that homeowners demand more input from our community, so they are not being take advantage of. He said they are also very concerned about the values of their properties being decreased due to the Solar Farm. He said there should be a baseline on the value of their properties now before the project is started. He also said NextEra received 350 million dollars in subsidies from New York State

and more likely than not, attached to that 350-million-dollar subsidy are timelines and payouts will occur.

Councilman Pfieffer asked Mr. Wutitsch if they are proposing that homeowners get a payout now of 5 to 7 percent. Mr. Wutitsch said no that is not the case.

Supervisor Trout explained about the property value protection plan for residents around the solar project. He said that there seems to be a fear by residents that their home values will be negatively affected. He said that the property protection plan would require at the time of sale three independent appraisals that would be required and the town would use Community Benefit Funds to make up the difference if there was a shortfall in the sale of the home. Supervisor Trout also said the Community Benefits money should be around sixty thousand dollars a year and the town plans to create a reserve account and hold around two hundred thousand dollars in reserves in case the town needs to enact the plan.

Doyle Security has taken over and much of the equipment that ELTEC used Doyle Security does not use and they are having problems with it.

Jim feels that the town should reach out to Doyle Security and have them look at all the equipment and possibly get new equipment.

Supervisor Trout said to get in touch with Doyle Security and get a price on updating the security system.

Supervisor Trout said that Highway Superintendent, Joe Mull said he wanted to thank the Municipalities of the City of Geneva, The Towns of Junius, Fayette and Seneca Falls for helping us Paving all the Border City Roads.

MRB Engineer, Mr. Patrick Nicoletta addressed the Board and said the sewer/manhole rehab project will start in August although he doesn't have an exact date yet.

Mr. Nicoletta also said the Evoqua Contract for hydrogen sulfide has been signed and they will start about six weeks after they receive the contract.

He also addressed the board about the South Pre-Emption Street Water and said USDA is still working on it and it should go to the underwriters soon. There was discussion about the high price of materials and Supervisor Trout said he doesn't know if the project can go forward.
